Introduction

Introduction: This unit is designed to produce a ground fog effect to enhance dance floors, entry ways, and for halloween effects. Included with this unit is a timer remote control. Please read the following instructions and safety precautions before attempting any installation or using your new Mister Kool II

- Be sure to save the packing carton in the unlikely event the unit may have to be returned for service
- Do not spill water or other liquids into or on to your fogger. Be sure that all the fog fluid is kept inside the fluid reservoir
- Be sure that the local power outlet match that or the required voltage for your fog machine
- Do not remove the top cover under any conditions. There are no user serviceable parts inside
- Disconnect the unit's main power when left unused for long periods of time
- Never connect this unit to a dimmer pack
- Do not attempt to operate this unit, if it becomes damaged in anyway
- · Never operate this unit when it's cover is removed
- To reduce the risk of electrical shock or fire, do not expose this unit rain or moisture
- Do not attempt to operate this unit if the power cord has been frayed or broken. Do not attempt to remove or break off the ground prong from the electrical cord. This prong is used to reduce the risk of electrical shock and fire in case of an internal short
- Disconnect from main power before making any type of connection
- Never block the ventilation holes. Always be sure to mount this unit in an area that will allow proper ventilation. Allow about 6" (15cm) between this device and a wall
- This unit is intended for indoor use only, use of this product outdoors voids all warranties
- · Always mount this unit in a safe and stable matter
- Please route your power cord out of the way of foot traffic. Power cords should be routed so they are not likely to be walked on, pinched by items placed upon or against them

Warranty Registration

The Mister Kool II carries a one year (365 days) limited warranty. Please fill out the enclosed warranty card to validate your purchase. All returned service items whether under warranty or not, must be freight pre-paid and accompany a return authorization (R.A.) number. The R.A. number must be clearly written on the outside of the return package. A brief description of the problem as well as the R.A. number must also be written down on a piece of paper included in the shipping carton. If the unit is under warranty, you must provide a copy of your proof of purchase invoice. You may obtain a R.A. number by contacting our customer support team on our toll free customer support number. All packages returned to the service department not displaying a R.A. number on the outside of the package will be returned to the shipper.

Set-Up

- 1. Open the shipping carton and carefully remove the unit from the shipping carton.
- 2. Be sure to remove all the packing material especially around the nozzle.
- 3. Set the machine on a flat dry surface and unscrew the knob on the top of the unit. Open the top of the unit, and fill the inside of the Mister Kool with ice.
- 4. Remove the reservoir cap located on the top of the machine.
- 5. Fill the Mister Kool II reservoir with American DJ brand fog juice only and replace the cap.
- 6. Insert the water tube into the water bag. When the ice melts, the water will empty into the bag.
- 7. Remove the remote control from the carton. Firmly attach the remote control to the remote control socket located on the rear unit.
- 8. Plug the unit into a matching power supply and flip the power switch to the on position.
- 9. Follow the operating instructions on the next page for proper remote operation.

Always be sure to maintain an adequate supply of American DJ_{\otimes} Brand Fog juiceTM in the fluid reservoir. Running the fog machine dry will cause pump failure and or clogging. This is the largest cause of failure in fog and fog machines.

Mister Kool II

This unit has a 3 minute warm up time. After the unit is warmed up follow the directions below for ground fogger operation.

Remote Operation: The remote allows the unit to run manually or by timer. The remote has a "on/off" button, that activates the timer function. A yellow LED above the on/off button will glow when the timer function is activated.

Continuous: The remote has a red Continuous button, this button allows continuous output. Fog will continue to emit as long as this button is pushed in. A red LED above this button will glow when the continuous operation is active.

Manual: The remote has a green button, this button allows operation to be controlled manually. Fog will emit as long as this button is pushed, a green LED above this button will glow when the machine is warmed up and ready to emit fog.

Timer: The timer function allows fog to be emitted at designated intervals. To activate the timer function press the yellow timer button. A yellow LED will glow when the timer function is activated. The "duration" knob will control the length of fog burst. The "interval" knob will control the time between burst. Turning these knobs in a clockwise direction will increase there values, turning them in a counter-clockwise direction will decrease their values.

Trouble Shooting

If you experience low fog output, pump noise, or no fog output at all, disconnect and discontinue use immediately. Do not continue pushing the remote control's activation button as this may damage the Mister Kool II. Check fluid level, the external fuse or breaker, remote connection, and be sure the wall outlet is sending power. If all of the above appear to be okay, and the unit fails to operate correctly, the unit may require service. Please contact customer support for further instructions. Please do not return the unit to your dealer without contacting customer support first.

Mister Kool II Proper Storage and Maintenance

When storing your fog machine be sure to store it in a cool area. Cover the machine so that dust does not build up on the unit. When storing the machine for long periods of time, it is highly advised to at least run the machine every 3-4 months. Long periods of inactivity can severly shorten the life of your machine. Only run water based fog juice through your machine. Never run plain water, vinegar, or any other liquid solution through your machine. Running anything other then water based fog juice will severly damage your machine.
